From the Sheriff

For the Clay County Sheriff's Office, the year 2023 could best be characterized by projects. While they may have been a little painful at the time, all had the same goal: to improve our service to the people of Clay County.

The Detention Center underwent a major renovation of its electronic control systems, causing substantial change to the way we normally operate and forcing us to reduce the inmate population for many months (p. 17). Our staff showed amazing adaptability and perseverance during this time.

The implementation of a new records management system (p. 30) modernized many aspects of our operations, from report writing to inmate tracking. It also allows us interoperability with many of our neighboring agencies. It does categorize many things differently, however, so you will see some statistics in this report that do not have year-over-year comparisons due to items not being categorized the same as in prior years.

Our Drug Task Force partnered with a new Patrol squad to tackle quality-of-life issues like drug houses (p. 25). Many residents have reached out about how much they appreciated these efforts to improve safety in their neighborhoods.

I'm pleased to share this snapshot of what the men and women of the Clay County Sheriff's Office accomplished in 2023.





At the end of 2023, the Sheriff's Office had 215 fulltime employees split into two bureaus. Their assignments are shown on this chart.






Provisional Hiring Process Implemented

To help with recruitment efforts, the Sheriff's Office implemented a provisional hiring process in February 2023. This dramatically sped up the hiring process and led to sought-after candidates choosing Clay County because it was the first to extend a job offer. In this process, the background investigator conducted a preliminary background investigation before other things like interviews could proceed, but the full investigation was not complete at the time a job offer was made. Candidates were notified their employment could be terminated if the full investigation revealed they were disqualified. This streamlined process led to some qualified candidates being hired in as short as a week's time, compared to the months-long process previously in place.








2023 Budget Allocation

The Sheriff's Office's total budget in 2023 was \$26,461,522. Below is where that money was spent.





Includes medical and mental health services for the Detention Center, food service for the Detention Center, vehicle maintenance and repair, etc.




Commodities








Accreditation Progress

In 2023, the Sheriff's Office was pursuing accreditation from both the National Institute of Jail Operations (NIJO) and the Commission on Accreditation for Law Enforcement Agencies (CALEA). Accreditation by both organizations is an intensive, multi-year process that began in 2021.






Construction Forced Changes


The Clay County Detention Center underwent significant renovations in 2023. The greatest was the complete replacement of the electronic control systems. This caused considerable temporary changes. Beginning the first week of April, all doors had to be manually locked and unlocked with keys. This staff-intensive process meant inmate population had to be reduced. Detention staff accomplished this by not accepting municipal inmates and by housing out as many as 60 to 70 inmates daily to other county jails. This led to a great increase in trips for the Transportation Unit.

The \$2 million project, funded by federal pandemic relief dollars, was supposed to be completed by August. Contractor issues, however, led to the jail not being fully operational again until Dec. 20.

Court Security Unit

The Court Security Unit provides security at Clay County Circuit Court, and deputies serve as courtroom bailiffs.



Transportation Unit

The Transportation Unit is responsible for all inmate movement outside of the Detention Center. They ensure inmates are where they need to be, when they need to be. They also perform extraditions.



Penitentiary Transport - Transportation to and from state prisons

Metro Transfers - Local transfers, including adjoining counties

Writ/Return - State Department of Correction inmates picked up and returned on a court-ordered writ to appear in person in Clay County Court.

Mental Evaluation – Generally transported to St. Joseph or Kansas City per court order for an evaluation. Doctor Appointment – Scheduled by jail medical staff to an outside area medical facility

Housed-Out Inmate – Transporting inmates that are housed out at local facilities per the Detention Center's request. The Transportation Unit provided for initial housing plus court returns.

Municipal - Transport of inmates from area municipalities

Out-of-State Extradition – Returning inmates outside of Missouri to stand trial in Clay County.

<u>In-State-Extradition</u> – Returning inmates inside Missouri to stand trial in Clay County

<u>Juvenile</u> – Transport of juvenile defendants





Operation nets child predators

The Clay County Sheriff's Office and Homeland Security Investigations (HSI) Kansas City worked together to arrest four men seeking to engage in sexual activity with children during the time period of the NFL Draft in Kansas City.

From April 26 to 30, four men traveled to Clay County to meet with whom they believed to be children ranging in ages from 10 to 14. They had chatted online previously with the "children," (really Clay County Sheriff's Office and HSI-KC investigators) or with adults who were purportedly offering the children for sex (also under-cover Sheriff's Office and HSI-KC investigators). Deputies arrested the men shortly after their arrival at either the designated apartment or hotel room.

The suspects hailed from Oregon to New Jersey.



Community Interaction Deputy increases outreach

Records management system updated

For the first time in 20 years, the Sheriff's Office upgraded its electronic records management system. The software change impacted nearly every operation of the Sheriff's Office. Led by Captain Jon Bazzano and Lieutenant Larry Tarrant, 14 Sheriff's Office members built the program to meet the agency's specific needs. The new software, Central Square, was the same used as numerous other law enforcement agencies in Kansas City, North. With its implementation, intelligence and information-sharing increased dramatically.

Sheriff Will Akin created a full-time Community Interaction Deputy position in June 2023, assigning Corporal Megan Blackburn to the role. He said he wanted to be more deliberate about the Sheriff's Office's community engagement. Cpl. Blackburn organized community outreach events, helped find resources for homeless individuals, targeted nuisance properties with multiple code violations and instructed crime prevention through environmental design training.


Strategic Operations Squad targets issues

The Strategic Operations Squad launched on June 24, 2023, to proactively target crime issues that negatively affect residents' quality of life. They operated as another shift of Road Patrol. SOS worked with the Drug Task Force to shut down five drug houses and arrest the dealers. They also located and arrested three homicide suspects, stopped teen "fight clubs" meeting in parks, and assisted Liberty Police in operations to deter retail theft.






Patrol Area



Civil Service Definitions

Affidavit -

A written statement of facts voluntarily made. Usually to modify child support when a child comes of age

Ex-Parte -

Orders that can be granted without waiting for a response from the other side. Usually no-contact orders

Execution -

The execution of a legal order not otherwise categorized herein

Garnishment -

Served to employers to garnish the wages of an employee who has been court-ordered to pay a debt

Levy -

The court-ordered seizure and sale of property to collect money for a debt

Civil Service Definitions

Nulla Bona -

A writ returned to indicate that no goods were obtained that can be used to satisfy a legal action for debt or damages

Probate -

Orders from Probate Division, usually for guardianship or mental health treatment

Post Serve Mail -

A type of notice deputies can post at an address without making personal contact. A copy of the notice also is mailed to the address

Replevin -

An action to recover personal property that was unlawfully taken. Usually property purchased on a payment plan for which payments were not made

Restitution -

Eviction

Subpoena -

An order to appear in court at a specified time and date after a court case has begun

Summons -

Similar to a subpoena – an order to appear in court – but at the beginning of a court case

Writ -

A court order commanding the recipient to perform or cease a specified act
